5. Pre-bid meeting shall be held at **Dangisharan Rural Municipality, Hekuli, Dang** on **2077/12/09** at **14.00 hours**.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12.00 hours** on **2077/12/22**. Bids received after this deadline will be rejected.
7. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00 hours** on **2077/12/22** at the office of Dangisharan Rural Municipality, Dang.
8. Bids must be valid for a period of 120 days in counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in below table, cash deposit Account No.:**114000016 301**, with account name : **GA 3 DHARAUTI KHATA**, Nepal Credit and Commerce (NCC)Bank Ltd. ,Hekuli Dang branch or in the form of unconditional Bank guarantee from A class Bank in favor of Dangisharan Rural Municipality ,Office days counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in below table, cash deposit of the Rural Municipal Executive ,Hekuli Dang, which shall be valid for minimum 30 days beyond the bid validity period.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as . specified for the original last date of bid submission.
10. Bidders may withdraw or modify its bids by sending a written notice in a sealed envelope, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB 20.2 before 24 hours prior to the deadline of submission of bids.
11. Bidder may submit modification or withdrawal prior to the deadline prescribed for submission of bid through e- GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
12. After the completion of evaluation of Technical Bids which are substantially responsive evaluated bidders, will be invited to attend the opening of Price Bids. The date, time and location of opening of Price Bid shall be notified in writing and/or published in national daily.
13. Other mandatory information will be as per Public Procurement Act 2063 and (PPA) and Public Procurement Regulation 2064 (Amended).
