## Invitation for Bids

Invitation for Bids for the **Construction of Kalam Khola Bridge at Dangisharan RM-2, Dang**

1. The Nepal Government *has allocated funds* towards the cost of **Construction of Kalam Khola Bridge at Dangisharan RM-2, Dang** and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible as per Section V of bidding document..
2. **Dangisharan Rural Municipality Office, Dang** invites electronic bids from eligible bidders for the **Construction of Kalam Khola Bridge at Dangisharan RM-2, Dang** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

7. Bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egpon](http://www.bolpatra.gov.np/egpon) or before **12:00** on **April 28, 2021**. Bids received after this deadline will be rejected.
8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **13:00** at **April 28, 2021** the office of **Dangisharan Rural Municipality Office, Hekuli, Dang**.
9. Bids must be valid for a period of 90 days in counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in below table, cash deposit Account No.:**1140000016 301**, with account name : GA 3 DHARAUTI KHATA, Nepal Credit and Commerce (NCC)Bank Ltd. ,Hekuli Dang branch or in the form of unconditional Bank guarantee from A class Bank in favor of Dangisharan Rural Municipality ,Office days counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in below table, cash deposit of the Rural Municipal Executive ,Hekuli Dang,which shall be valid for minimum 30 days beyond the bid validity period.
