The Bidding Documents may be purchased by the eligible bidders on submission of a written application attaching attested copies of (a) firm registration certificate (b) VAT and PAN registration form and (c) tax clearance certificate, valid for F/Y 2073/74) Power of Attorney, and upon payment of a non-refundable fee (Cost for bid document) of as mentioned in above table for bidding documents from the DRM Procurement Unit within office hours.
3. Separate Sealed Bids for each Contract identification Number must be submitted to Dangisharan Rural Municipality(DRM),Dang on or before 1:00 PM on 2075/01/26. Documents received after this deadline shall not be accepted. Late bids will be rejected. Bids received by the above mentioned deadline shall be opened physically in the presence of Bidders' representatives who choose to attend at the address above at 2:00 PM on 2075/01/26.
4. Bids must be valid for a period of 90 days and counting from the day of bid opening and must be accompanied by bid security of amount mentioned above, from "A" class Commercial Bank which shall be valid for minimum 30 days beyond the bid validity period. If the bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the bank account No. 4160303007102 of DRM Office at Nepal Banijya Bank, Tulsipur Branch.
5. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
6. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
7. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever. Any amendments to this notice shall be published in the notice board of DRM Administration Section..
8. The matter not specified in this notice and the Bidding Document, follows the prevailing laws (Public Procurement Act, 2063 & Public Procurement Regulation, 2064) of Nepal.
